- 2) Continue the public hearing to August 11, 2010.


DISCUSSION:

Prior to the July 14, Planning Commission meeting, staff distributed working draft copies of the General Plan Elements that included edits in response to items flagged by the Commission. Changes from the March draft are highlighted in yellow if viewing the document electronically, which shows as being shaded on hard copies. The strikeout format represents text being deleted and underline represents new text. Where a box includes the entire policy, the policy has been edited without strikeout and underline for clarity. Text boxes also include a brief statement as to the basis of the change.


During the July 14, Planning Commission meeting the Commission reached tentative agreement on the following sections and elements: Introduction, Land Use, Circulation, Conservation/Open Space, Safety, Agriculture, Economic Development, Agricultural and Winery Corridor Plan, and Carmel Valley Master Plan.

Remaining matters to review include: Cachagua Area Plan, Central Salinas Valley Area Plan, Greater Monterey Peninsula Area Plan, Fort Ord Master Plan, Greater Salinas Area Plan, North County Area Plan, South County Area Plan, Toro Area Plan, Glossary, and Public Services.

The Commission continued the hearing to July 21 and passed a motion to undertake review of the area plans first and then finish review of the Public Services element. Upon completion of the Planning Commission review of the flagged items, consideration of the General Plan should be continued to the Planning Commission meeting of August 11, 2010, at which time the Commission can adopt their recommendation to the Board of Supervisors.
