RECOMMENDATIONS:

It is recommended that the Board of Supervisors:

- a. Approve the Plans and Special Provisions for 1410 Natividad Rd, Salinas, California - Upgrade Security Fencing, Project No. 8529, Bid Package No. 10348; and
- b. Authorize the Director of Public Works to advertise the “Notice to Contractors” in *The Californian*.

SUMMARY/DISCUSSION:

Approval of Plans and Special Provisions authorizes the Department of Public Works to proceed with the advertising for the 1410 Natividad Rd, Salinas, California - Upgrade Security Fencing, Project No. 8529, Bid Package No. 10348 (Project). The bid opening is set for March 29, 2012, at 2:00 p.m., in the Board of Supervisors’ Conference Room 1032, Monterey County Government Center, 168 West Alisal Street, 1st Floor, Salinas, CA 93901. The Project is scheduled to begin in June 2012, with completion anticipated by August 2012.

Work to be done for the base bid elements consists of, in general, repair and replacement of existing perimeter fencing materials and installation of new barbed wire and other materials. Scope for additive alternates include placement of those same materials in zones considered less vulnerable. The County will option for additive alternates only if supported by the existing project budget. The Engineer’s estimate for construction of the base bid elements and all additive alternates is \$241,700.

OTHER AGENCY INVOLVEMENT:

The Office of the Sheriff, Custody Operations Bureau, has reviewed and approved the plans and special provisions. The Office of the County Counsel, Auditor-Controller, and Risk Management, have reviewed and approved the Special Provisions as to form and legality, fiscal terms, and insurance provisions, respectively.

FINANCING:

There is no impact to the General Fund. This Project has been fully funded by prior Board actions. The total Project budget is \$350,000 and total costs for the Project to date are \$52,211.
