

**RENEWAL AND AMENDMENT NO. 6 OF AGREEMENT
BETWEEN THE COUNTY OF MONTEREY &
ARAMARK CORRECTIONAL SERVICES (RFP#10001)**

WHEREAS, Aramark Correctional Services, LLC, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY" previously entered into an agreement dated November 29, 2007, for the provision of inmate commissary items and food service operations ("AGREEMENT"); and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT previously on June 19, 2008 via Amendment No. 1, on June 18, 2009 via Amendment No. 2, September 18, 2009 via Amendment No.3, on April 29, 2010 via Amendment No. 4, and on April 29, 2011 via Amendment #5.

WHEREAS, the AGREEMENT expired pursuant to its terms on November 29, 2011; and

WHEREAS, COUNTY and CONTRACTOR wish to renew the AGREEMENT retroactive to November 30, 2011; and

WHEREAS, COUNTY and CONTRACTOR wish to extend the term of the renewed AGREEMENT through and including August 31, 2012; and

WHEREAS, COUNTY and CONTRACTOR wish to extend the end date in EXHIBIT A-MEAL PRICE SCHEDULE, attached hereto; and NOW THEREFORE,

For valuable consideration, the sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:


1. Paragraph 1.0 TERM OF AGREEMENT, shall be amended to read as follows: "This Agreement shall be in full force and effect, commencing from the time of the signed Agreement through August 31, 2012.
2. Paragraph 2.0 COMPENSATION AND PAYMENTS, shall be amended to read as follows: "The end date to EXHIBIT A-MEAL PRICE SCHEDULE-07/01/2011 will be extended to August 31, 2012, attached hereto".
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this RENEWAL AND AMENDMENT NO. 6 TO AGREEMENT (RFP# 10001), and shall continue in full force and effect as set forth in the AGREEMENT;
4. A copy of this RENEWAL AND AMENDMENT NO. 6 shall be attached to the original AGREEMENT dated November 29, 2007.


