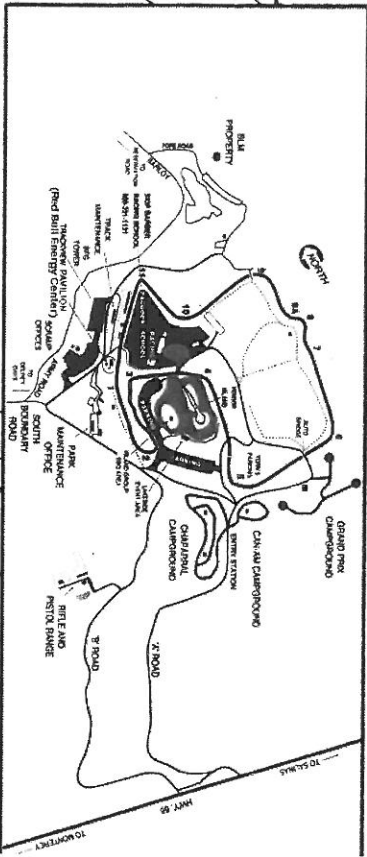

**RULES AND REGULATIONS**

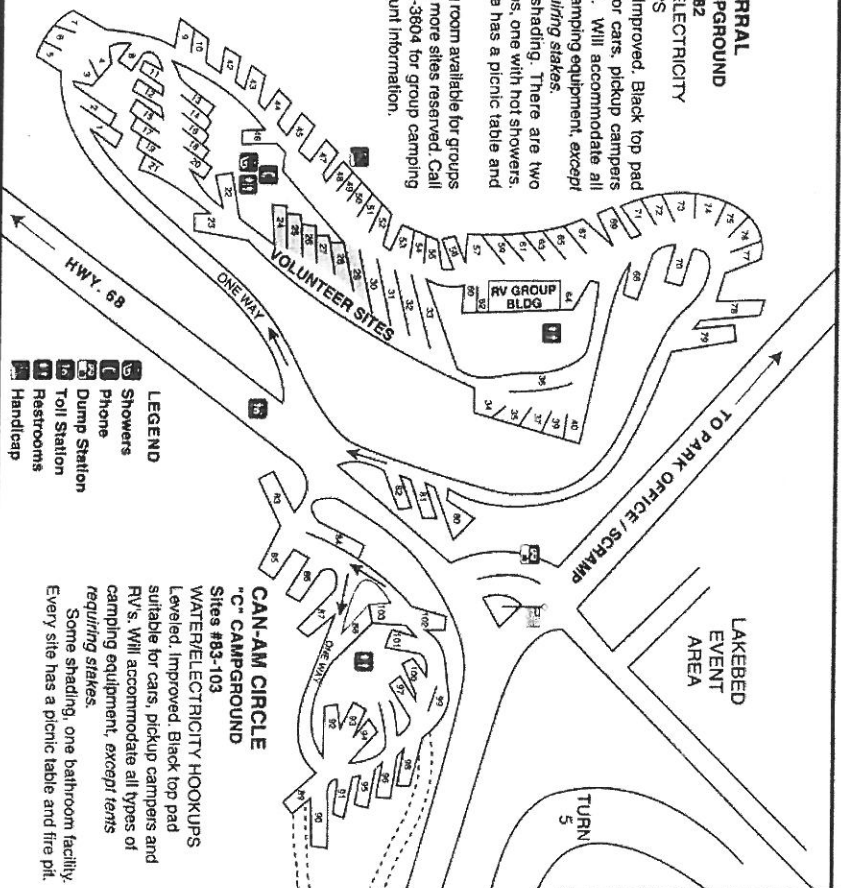
- \* Park, use fires, fire and propane, upon entry into the park.
- \* Campfire fee includes one vehicle.
- \* All vehicles are subject to search for the state vehicle and dogs.
- \* All vehicles must remain on the pavement. All vehicles parked in the campsite must be removed from the site by 10:00 A.M. on the morning you are due out.
- \* Each campsite may have up to eight people maximum.
- \* Check-out and check-in time is 2:00 P.M. If you do not leave a reservation and wish to re-register, please do so before 9:00 A.M. the morning you are due out.
- \* Quiet hours are from 10:00 P.M. to 7:00 A.M.
- \* No electronic equipment, including radios, may be used which emits a sound beyond the campsite perimeter.
- \* Campground fires are permitted only in the fire rings provided. No ground fires are allowed.

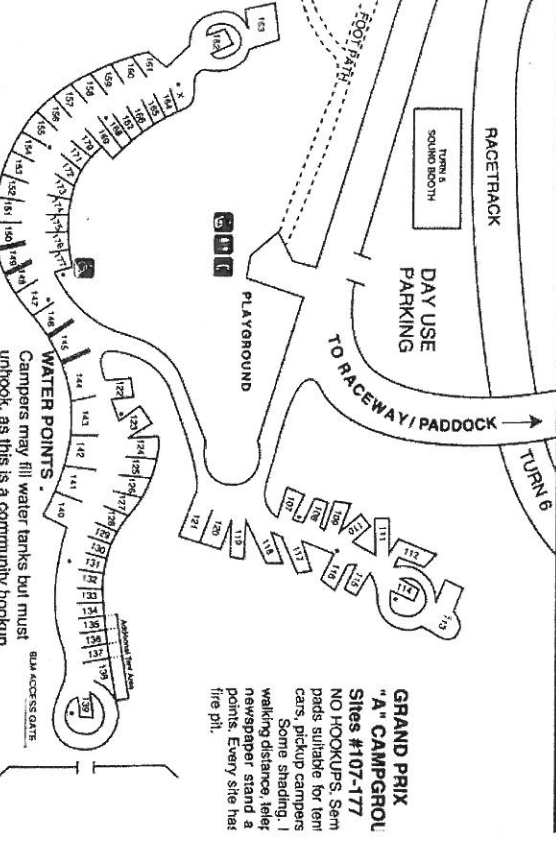
**CHAPARRAL "B" CAMPGROUND**
