WHEREAS, The Santa Cruz County Farm Bureau, Farmer of the Year award is presented annually to the farmer(s) who have contributed beyond their normal farming duties to help the community. "*Undisclosed Recipient*" was selected as the "2011 Farmer of the Year" award recipient; and,

WHEREAS, "*Undisclosed Recipient*" was born in Covina, Ca and grew up in Azusa, Ca. He graduated from Citrus Union High School and served in the US Army for 2 years. He graduated from Cal Poly Pomona with a degree in Agricultural Biology and worked as a part-time instructor at Cal Poly while studying Landscape Architecture; and,

WHEREAS, "*Undisclosed Recipient*" worked for the Neil A. Maclean Company from 1962 to 1975 as a soil specialist, sales manager and later Vice President of Agricultural Sales. From 1975 to 1989 he served as President of Soil Chemicals Corporation in Hollister. Pursuing a long-time interest in ornamental horticulture he took partial leave of absence from his job to explore the formation of a new wholesale nursery on the Leonard Coates Nursery property in Watsonville; and,

WHEREAS, "*Undisclosed Recipient*" formed a wholesale nursery corporation, Suncrest Nurseries, Inc., with the assistance of Trical Management. His professional background in pest management was helpful when the Light Brown Apple Moth infestation occurred. Stan is very proud of the fact that the nursery now recycles 50% of its irrigation water; and,

WHEREAS, "*Undisclosed Recipient*" is one of the "movie stars" in the very popular 2011 Santa Cruz County Agriculture video. He is a long time supporter of Saratoga Horticulture Foundation where he has been a volunteer, docent and advisor since 1978; and,

WHEREAS, "*Undisclosed Recipient*" currently lives in Los Gatos, is married and a father of 3 children and grandfather of 2.
