**WHEREAS, the *Honorable Nat A. Agliano***, was a member of the Judicial Council Sentencing Practices Advisory Committee, President-Elect of the Monterey County Bar Association, and the Note and Comment Editor of the Hastings Law Review, he was honored by the Monterey Peninsula College Hall of Fame and the University of California Hall of Fame; and

Agliano***, has served in the following capacities: Deputy Attorney General from 1960-1963; Private Attorney from 1963-1971; Judge of the Monterey County Superior Court from 1972-1984; Associate Justice of the California Court of Appeal, Sixth Appellate District from 1984-1986; Presiding Justice of the California Court of Appeal, Sixth Appellate District from 1986-1992; and, Justice Pro-Tem of the California Supreme Court in 1990.
