

# Notice of Public Hearing on Adoption of the Airport Land Use Compatibility Plan (ALUCP) for Monterey Regional Airport

## Monterey County Airport Land Use Commission

**NOTICE IS HEREBY GIVEN** that the **Airport Land Use Commission of the County of Monterey (ALUC)**, State of California, will hold a public hearing to consider adoption of the Airport Land Use Compatibility Plan (ALUCP) for the Monterey Regional Airport. Pursuant to state law (Public Utilities Code section 21675), the Airport Land Use Commission is charged with adopting airport land use compatibility plans to provide land use compatibility policies and criteria related to proposed development in the vicinity of public airports. The proposed ALUCP is a comprehensive update of the previously adopted 1987 Comprehensive Land Use Plan for Monterey Peninsula Airport (1987 CLUP). If adopted, the proposed ALUCP will replace the 1987 CLUP, including all text and figures. The ALUC will also consider adoption of a Negative Declaration for the ALUCP prepared pursuant to the California Environmental Quality Act (CEQA).

**NOTICE IS FURTHER GIVEN** that the public hearing on the above-described Negative Declaration and ALUCP will be held on **Monday, February 25, 2019** at the hour of **3:00 p.m.**, in the Monterey Peninsula Airport District Board Meeting Room, Monterey Regional Airport, 200 Fred Kane Drive, Suite 200, Monterey, California, at which time and place any and all interested persons may appear and be heard thereon.
