5150 APPLICATION FORM UPDATES

The Application for Assessment, Evaluation, and Crisis Intervention or Placement for Evaluation and Treatment (DHCS form 1801 (06/18)) form has been updated. The following are new elements of the "5150 Application." The "5150 Application" form is now 2-pages long with an additional 2-pages with information on definitions and references. Page 3 contains reference information on the new element, "information about the historical course of the person's mental disorder," on the "5150 Application."
