1 Policy

2

3 Monterey County Behavioral Health (MCBH) shall ensure that each of its County staff and its
4 contracted providers who deliver covered services is qualified in accordance with current legal,
5 professional, and technical standards, and is appropriately licensed, registered, waived, and/or
6 certified. County staff and its contracted provider staff must be in good standing with the
7 Medicaid/Medi-Cal programs. Any County staff or contracted provider staff excluded from
8 participation in Federal health care programs, including Medicare or Medicaid/Medi-Cal, may not
9 participate in any MCBH's network of providers.

11 Procedures

13 A. Credentialing and Verification Procedure

14

15 For all licensed, waived, registered and/or certified mental health providers:

16

- 17 • Licensed Clinical Social Workers;
- 18 • Licensed Marriage and Family Therapists;
- 19 • Licensed Professional Clinical Counselors,
- 20 • Waivered/registered,

22 For all licensed, waived, registered and/or certified substance use treatment providers:

23

- 24 • Registered/certified Alcohol and Other Drug counselors (AOD)
- License Practitioners of the Healing Arts (LHPA)

- 25 ○ Physician
- 26 ○ Nurse Practitioners
- 27 ○ Physician Assistants
- 28 ○ Registered Nurses
- 29 ○ Registered Pharmacists
- 30 ○ Licensed Clinical Psychologists
- 31 ○ Licensed Clinical Social Worker
- 32 ○ Licensed Professional Clinical Counselor
- 33 ○ Licensed Marriage and Family Therapists
- 34 ○ License Eligible Practitioners working under the supervision of licensed
- 35 clinicians

37 MCBH and its contracted providers shall verify and document the following items through a
38 *"primary source,"* as applicable, prior to employment. Primary source refers to an entity, such as
39 a state licensing agency, with legal responsibility for originating a document and ensuring the
40 accuracy of the document's information. Monterey County Behavioral Health Human Resources
41 department and its Contracted Providers staff shall verify the following, as applicable:

- 42
- 43 1. Evidence of graduation or completion of any required education, as required for
- 44 the particular provider type
- 45 2. Proof of completion of any relevant medical residency and/or specialty training, as
- 46 required for the particular provider type
- 47 3. The appropriate license and/or board certification or registration, as required for
- 48 the particular provider type
- 49 4. Satisfaction of any applicable continuing education requirements, as required for
- 50 the particular provider type

52 MCBH and its contracted providers shall verify and document the following items (verification
53 does not need to be through a primary source). Monterey County Behavioral Health Human
54 Resources department and its Contracted Providers staff shall verify the following, as
55 applicable:

- 56
- 57 1. Work history
- 58 2. Current Drug Enforcement Administration (DEA) identification number
- 59 3. History of sanctions or limitations on the provider's license issued by any state's
- 60 agencies or licensing boards.
- 61 4. National Provider Identifier (NPI) number
- 62 5. Current malpractice insurance in an adequate amount, as required for the
- 63 particular provider type
- 64 6. History of sanctions from participating in Medicare and/or Medicaid/Medi-Cal:
- 65 providers terminated from either Medicare or Medi-Cal, or on the Suspended and
- 66 Ineligible Provider List may not participate in the Plan's provider network. This list

- 68 7. Provider information, if any, entered in the National Practitioner Data Bank, when
- 69 applicable. See <https://www.npdb.hrsa.gov/>

- 71 Additional requirements for hospitals (verification does not need to be through a primary source)
- 72 1. Hospital and clinic privileges in good standing
 - 73 2. History of any suspension or curtailment of hospital and clinic privileges
 - 74 3. History of liability claims against the provider

76 Monterey County Behavioral Health, Quality Improvement, shall continue to check the following lists
77 on a monthly basis. MCBH shall continue to follow MCBH Policy 142 Excluded Providers to verify
78 MCBH staff and its contracted provider staff are *not* on the following lists:

- 80 1. United States (US) Social Security Administration (SSA) Death Master File (Death
81 Master File)
- 82 2. US Department of Health & Human Services (DHHS) Office of Inspector General (OIG)
83 List of Excluded Individuals/Entities (LEIE)
- 84 3. US System for Award Management (SAM; replacement for the US Excluded Parties
85 List System or EPLS)
- 86 4. The State of California (CA) MediCal List of Suspended or Ineligible Providers (S&I
87 List)

89 Additionally, MCBH Quality Improvement shall continue to follow MCBH Policy 107 Licensure
90 Requirements and Verification of Licensure and MCBH Policy 443 Scope of Practice.

92 B. Attestation

93

94 Upon successful completion of credentialing process, and every three (3) years thereafter, staff
95 shall review, sign, and date a statement attesting to the following:

96

- 97 1. Any limiting ability impacting their performance as it pertains to the essential functions
98 required of their role with or without accommodation
- 99 2. History for loss of license, or felony conviction
- 100 3. A history of loss or limitations of privileges, or disciplinary action
- 101 4. A lack of present illegal drug use
- 102 5. By signing, the practitioner is attesting to the accuracy and completeness of the
103 information

105 C. Re-Credentialing and Verification Procedure

106

107 Monterey County Behavioral Health shall continue to, on a monthly basis, run all MCBH staff and
108 contracted provider staff, who previously met the credentialing requirement through the excluded
109 provider lists as noted above and in MCBH Policy 142 Excluded Providers. MCBH shall continue to
110 follow MCBH Policy 107 Licensure Requirements and Verification of Licensure. Hospitals shall
111 continue to follow their re-credentialing procedures.
